

Pursuant to decision of the High Power Committee in its meeting held on 13.09.2013, **No Objection Certificate** is granted in respect of the following School for the purpose of obtaining affiliation from the CBSE with the terms and conditions noted hereunder:

1. The No Objection Certificate now issued shall be subject to the terms and conditions as prescribed in the G.O. No.30720/SME, Dt.23.09.96 and No. 29519, Dt.26.09.1998.
2. Medium of instruction in the School shall be English but Oriya shall be taught as a subject to all pupils in the institutions compulsorily except the domiciles of other states and pupils of public servant on transfer from other states.
3. The School shall be opened for inspection by the Inspecting Officers of School and Mass Education Department.
4. No financial assistance and grant-in-aid (both recurring and non-recurring) shall be claimed by the institution from the Government at any point of time for meeting the salary cost and its component towards teaching and non-teaching staff appointed by the Managing Committee.
5. The Managing Committee of the School will not shift the present location of the School without prior approval of Director, Elementary Education, Odisha.
6. The Managing Committee shall be constituted in accordance with the Section-7 of Orissa Education Act, 1969.
7. The Managing Committee shall ensure the continuity of all eligibility criteria for grant of N.O.C. if any deterioration from present status of the School is detected at any point of time then the N.O.C. shall be withdrawn.
8. All Schools be registered in web-portal in OPEPA website.
9. 25% of the seats will be reserved for admission of socially and economically backward students as per RTE Act.
10. For Class-VIII one trained graduate teacher (Science) and trained graduate (Arts) is compulsory.

11. If at any point of time, it is found that information submitted by the Schools is not in conformity with the field position, appropriate legal action against the school authority will be initiated besides withdrawal of NOC.


